TNB INKS MOU WITH ELIA, ONE OF EUROPE'S LARGEST TRANSMISSION SYSTEM OPERATOR

Tenaga Nasional Berhad ("TNB") has signed a Memorandum of Understanding ("MoU") with Elia System Operator SA ("Elia"), one of the largest Transmission System Operator in Europe, for a strategic collaboration in sharing of best practices in capacity building.

Ir. Azman also said that the MoU bodes well for TNB's Advanced Metering Infrastructure (AMI) project and ventures into RE, both locally and overseas.

Chief Infra Officer Elia Group & Chairman of Elia Grid international, Markus Berger, in his speech said with the MoU, Elia offers its expertise as TNB's anchor partner in achieving TNB's corporate and nation building vision.
