Our announcement dated 30 November 2017 of the above matter is hereby referred.

Tenaga Nasional Berhad ("TNB") wishes to announce that on 1 August 2018, Majlis Mesyuarat Kerajaan Negeri Perak Darul Ridzuan had amended the 4th Schedule of the Perak Coastal Management (Licensing, Fees and Charges) Regulation 2016 to state that the coastal charges and fees will be Zero ("0") rated (gazetted on 13 August 2018), which in effect means that Lekir Bulk Terminal Sdn. Bhd. ("LBTBSB") is no longer required in law to pay coastal charges or fees to the Perak Coastal Council.

LBTBSB is 80% owned by Pelabuhan Lumut Sdn. Bhd. ("PLSB") and 20% owned by Tuah Utama Sdn. Bhd. Integrex Berhad, a wholly owned subsidiary of TNB, holds 100% equity interest in PLSB.

In view of the above material development, LBTBSB has today withdrawn the application for Judicial Review against Majlis Pengurusan Pesisir Pantai Perak, Pengarah Majlis Pengurusan Pesisir Pantai Perak, Kerajaan Negeri Perak, Majlis Mesyuarat Kerajaan Perak Darul Ridzuan and Perbadanan Kemajuan Negeri Perak.
