Solar For Rakyat Incentive Scheme

**Solar For Rakyat Incentive Scheme, SolaRIS** is an incentive programme launched by the Government aimed at attracting new installations of solar photovoltaic (PV) systems in residential premises. This programme supports the government's goal of increasing renewable energy capacity in the electricity supply system to 70% by 2050 and reducing carbon emissions from the electricity sector.

A cash rebate of up to RM4,000 will be given to residential customers who submit Net Energy Metering (NEM) application to Sustainable Energy Development Authority (SEDA) from 1 April 2024 onwards and successfully commission their solar PV system installations with TNB.

## SolaRIS Eligibility



**TNB Residential Customers (Tariff A)**  
\*Exclude businesses

*\*Each customer is entitled to only ONE rebate*



**Successful first time NEM Rakyat applicants from 1 April 2024 onwards**

*Note : Customers with prior NEM approvals are not eligible*

## SolaRIS Features

- ✓ **One time cash rebate** : RM1,000/kWac up to a **maximum of RM4,000** for NEM Rakyat customers who apply and obtain approval from 1 April 2024 onwards.  
*\*Subject to the terms and conditions of the SolaRIS programme.*
- ✓ Rebate allocation is on a **first come, first served** basis from 1 April 2024 and successfully commission their solar PV system installations by 30 April 2025, or until all SolaRIS rebate quotas are fully distributed, whichever comes first.
- ✓ The rebate will be transferred to the preferred local bank account under the registered TNB customer after receiving an email from TNB for SolaRIS application.

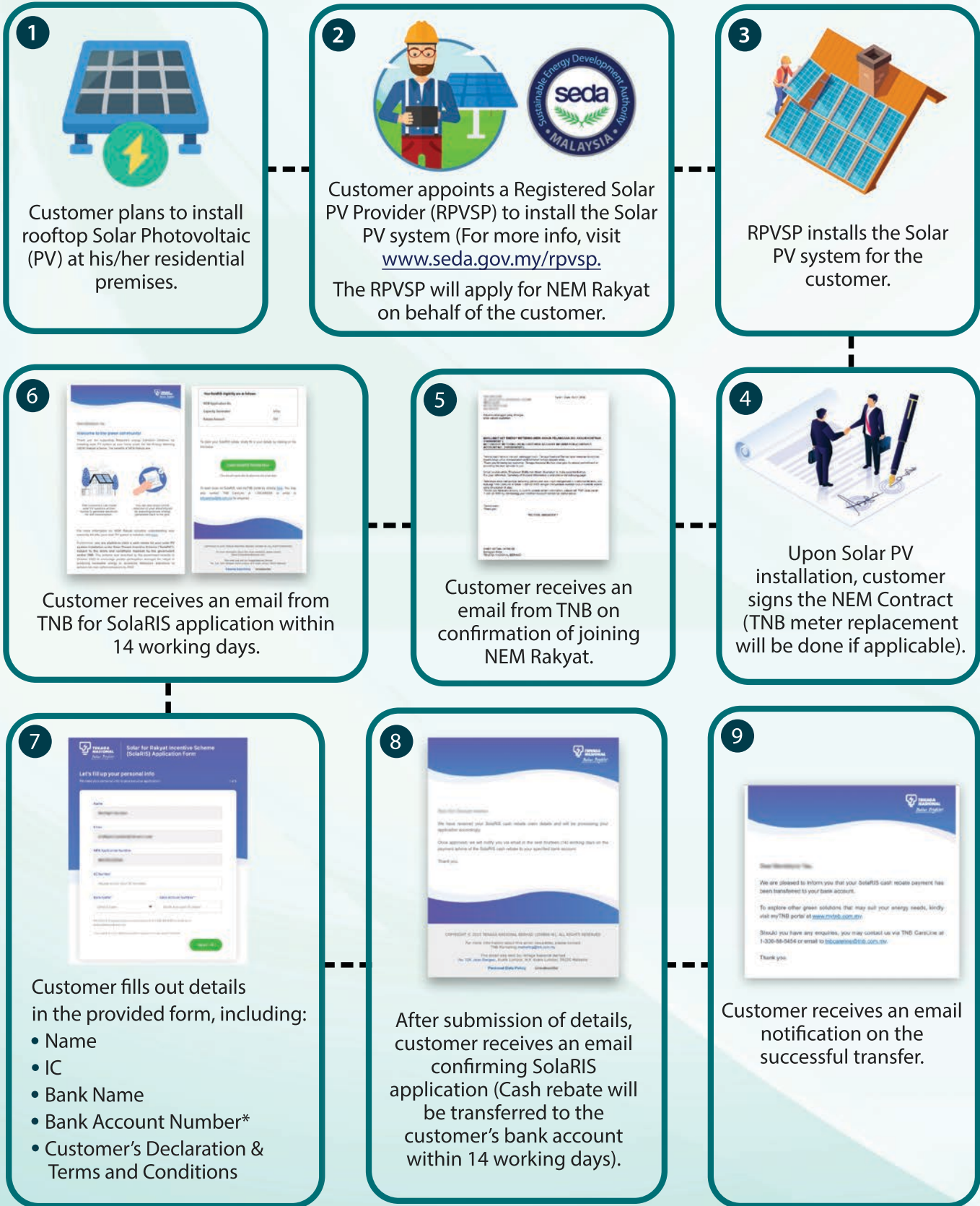

## How to apply for SolaRIS cash rebate



Customer plans to install rooftop Solar Photovoltaic (PV) at his/her residential premises.

Customer appoints a Registered Solar PV Provider (RPVSP) to install the Solar PV system (For more info, visit [www.seda.gov.my/rpvsp](http://www.seda.gov.my/rpvsp)). The RPVSP will apply for NEM Rakyat on behalf of the customer.

RPVSP installs the Solar PV system for the customer.

Upon Solar PV installation, customer signs the NEM Contract (TNB meter replacement will be done if applicable).

Customer receives an email from TNB on confirmation of joining NEM Rakyat.

Customer receives an email from TNB for SolaRIS application within 14 working days.

Customer fills out details in the provided form, including:

- Name
- IC
- Bank Name
- Bank Account Number\*
- Customer's Declaration & Terms and Conditions

After submission of details, customer receives an email confirming SolaRIS application (Cash rebate will be transferred to the customer's bank account within 14 working days).

Customer receives an email notification on the successful transfer.

\*The bank account details provided must belong to the TNB registered customer.
