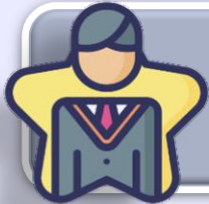

RENEWAL PROCESS

Certificate renewal can be done through SUS Portal by the following company:



A registered company who has existing TNB vendor (3xxxxxx)



A Temporary Vendor & Deleted Vendor (not exist in SUS Portal) who wish to register as TNB Registered Vendor are required to send an application to ssdproc@tnb.com.my



A Special Approval-Local (SAL) & Deleted vendor (exist in SUS Portal) who wish to register as TNB Registered Vendor is required to submit a renewal certificate application through SUS Portal

CERTIFICATE VALIDITY PERIOD

IMPORTANT OF COMPANY'S E-MAIL

Company that intend to register must ensure ALL official company e-mails are valid and active. The usage of any third-party e-mail address is prohibited and shall lead to the rejection of the application.

The official company e-mail will be used for the following functions in SUS Portal:

1. Creation of User ID and password for main user
2. Creation for additional User ID
3. Update of company information
4. Submit tender response
5. Reset password
6. Receive all e-mail notification
7. Receive reminder e-mail related to renewal of certificate on 45 and 30 days before the certificate expiry date





INFORMATION



A company who registered with TNB is eligible to participate in tender/quotation which will be published through SCMS or TNB corporate website



Any changes to the registration requirement are TNB rights.





A company that intends to register as a TNB supplier must warrant and ensure all data, information, and supporting documents provided to TNB are valid and accurate. If the company is found guilty of committing fraud or complicit in deceiving TNB by falsifying or misrepresenting any information or documents submitted to TNB, the company's application for registration will immediately be dismissed, and in the case of an application that has been approved, the approval will be immediately withdrawn. TNB is entitled to **blacklist indefinitely any parties** who are found guilty of fraud or being complicit in deceiving TNB.

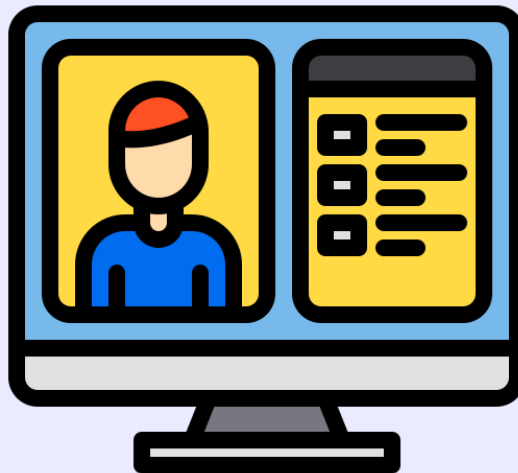
Below are some of the implications of a blacklist action:

1. All existing contracts with the supplier/contractor who is blacklisted shall not be continued.
2. A supplier/contractor who is blacklisted shall not be allowed to participate in any TNB procurement activity indefinitely.
3. A supplier/contractor who is blacklisted shall not be awarded any tender or contract beginning from the date when the blacklist measure towards the supplier/contractor is effective.
4. A supplier/contractor who is blacklisted shall not be a subcontractor to any other companies which have contracts with TNB.

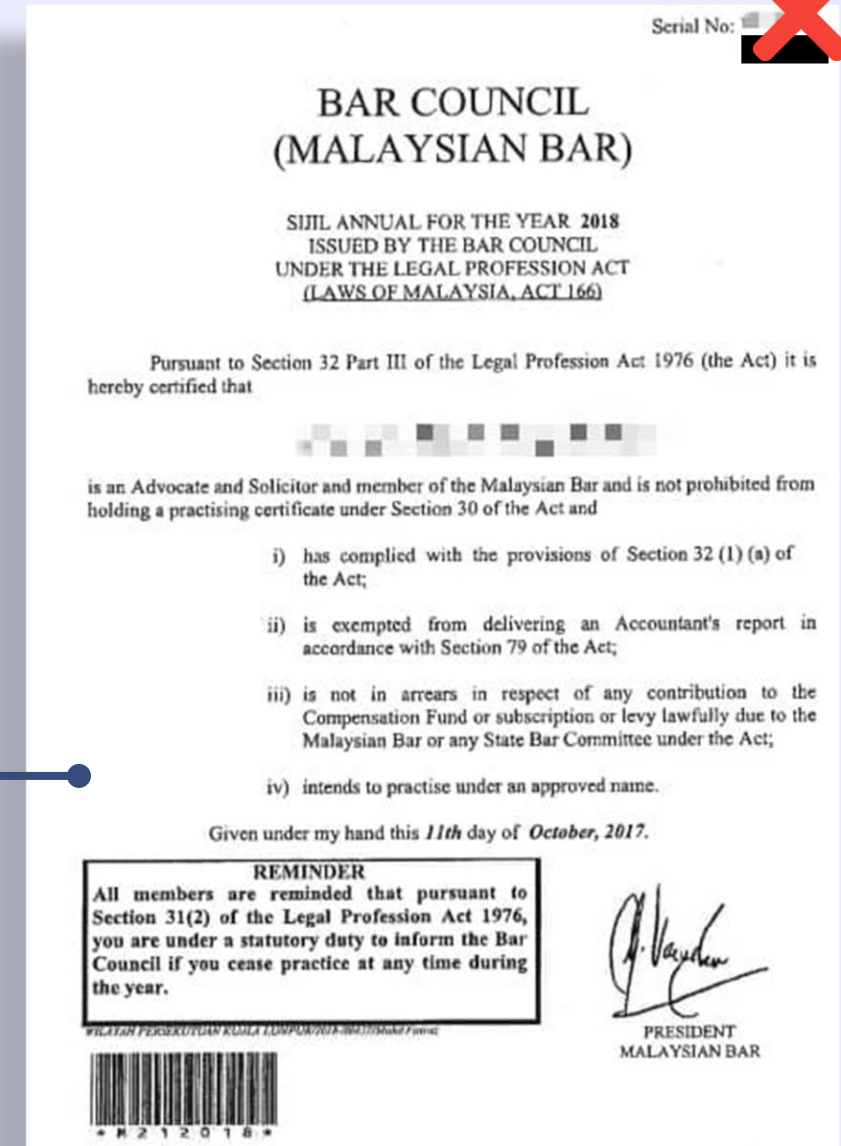
