TBSS2 is pleased to announce that it had received a notification letter from the EC on 10 August 2022 informing that EC has approved the following:-

- i. Extension of Time ("EOT") for the Financial Close Date ("FCD") from 30 June 2022 to 30 September 2022:
- ii. EOT for the Scheduled Commercial Operation Date ("SCOD") from the actual date of SCOD to 31 December 2023;
- iii. EOT for the effective period of PPA with four (4) years extension with a total period of 25 years; and
- iv. Related agreements and warranties to be extended and aligned with the latest effective PPA period of 25 years.

The Project is on track to achieve the FCD before 30 September 2022. The new effective period of the PPA will be stipulated under the Supplementary Agreement of PPA which will be signed between TNB and TBSS2. The signing of the Supplementary Agreement of PPA will enable the Project to optimize the returns and cushion the adverse impact due to increase of cost.
