

# Green Electricity Tariff

**Green Electricity Tariff (GET)** is a subscription-based solution catered for eco-friendly consumers and organizations with Environmental, Social, and Governance (ESG) goals to power residential and business premises with green electrons from renewable energy sources certified by Malaysia Renewable Energy Certificate (mREC).

For 2024, **6,600 GWh** GET quota is available for subscription. All TNB consumers can subscribe to GET via myTNB portal from **11.00 am, 3 May 2024** onwards.

## GET Features

### Consumers will pay :

1) **Standard tariff rates** as per Tariff Schedule applies for your total monthly electricity consumption



2) **GET premium subscription rate** of :

a) 10 sen/kWh for Residential tariff and low voltage Non-Residential tariff <sup>(i)</sup>

or

b) 20 sen/kWh for medium voltage and high voltage Non-Residential tariff <sup>(ii)</sup>

<sup>(i)</sup> Tariff Residential A, Commercial B, Industrial D, Mining F, Specific Agriculture H and Streetlight G1 & G2

<sup>(ii)</sup> Tariff Commercial C1, C2, C3 & C4, Industrial E1, E2 & E3, Mining F1 & F2 and Specific Agriculture H1 & H2

### Block Subscription :

Subscribe from a minimum of one (1) block and up to 100% of your average monthly electricity consumption



#### Residential

1 block = 100 kWh



#### Non-Residential

1 block = 1,000 kWh

\*On a first-come, first-served basis subject to TNB's assessment and quota availability.

### Subscription Period until 31 December every year.

GET subscription will be renewed automatically every year for a period of one year if there is no termination of subscription.



\*Terms & conditions apply.  
\*During the subscription period, reduction or termination is not allowed.



Option to backdate subscription\* effective date **from 1 January 2024.**

\* Applicable only for subscription from 3 May until 31 May 2024 only.  
Additional GET subscription charges apply from January to May 2024.

## GET Benefits



### Imbalance Cost Pass-Through (ICPT) Exemption

ICPT will not be charged in your bill for actual green energy used (limit up to the number of GET blocks subscribed).



### Internationally Recognised

Malaysia Renewable Energy Certificate (mREC) will be issued after the calendar year to certify total green electricity consumed for the year.
