E.EXPLANATORY NOTES

(Amounts in RM million unless otherwise stated)

1) BASIS OF PREPARATION

These unaudited condensed interim financial statements of the Group have been prepared in accordance with Financial Reporting Standards ("FRS") 134 "Interim Financial Reporting", issued by Malaysian Accounting Standards Board ("MASB") and paragraph 9.22 and Appendix 9B of the Listing Requirements of Bursa Malaysia Securities Berhad, and should be read in conjunction with the Group's audited financial statements for the year ended 31 August 2009.

The accounting policies, method of computation and basis of consolidation applied in these unaudited condensed interim financial statements are consistent with those used in the preparation of the audited financial statements for the year ended 31 August 2009 except for the adoption of FRS8 – Operating Segments effective 1 September 2009.

2) AUDIT QUALIFICATION

The annual audited financial statements for the financial year ended 31 August 2009 were not subject to any qualification.

3) SEASONAL OR CYCLICAL FACTORS

The businesses of the Group are not subject to material seasonal or cyclical fluctuations.

4) UNUSUAL ITEMS AFFECTING ASSETS, LIABILITIES, EQUITY, NET INCOME or CASH FLOWS

There were no unusual items of nature, size or incidence that affect the assets, liabilities, equity, net income or cash flows of the Group during the reporting period.

5) MATERIAL CHANGES IN ESTIMATES OF AMOUNTS REPORTED

There were no changes in the estimates of the amounts reported in the previous financial year that have a material effect on the results of the current reporting period.

6) DEBT AND EQUITY SECURITIES

- (a) TNB has repurchased USD71.6 million of TNB's USD150.0 million 7.50% Debentures due 2096. The total amount outstanding after the repurchase is USD78.4 million.
- (b) During the period, a total of 2,862,500 ordinary shares of RM1.00 each were issued under the Employee Share Option Scheme II ("ESOS II").

Except for the above, there were no other issuance, cancellation, repurchases, resales and repayments of debt and equity securities during the period under review.

7) DIVIDENDS PAID

In respect of the financial year ended 31 August 2009, TNB, on 24 December 2009, paid a final dividend of 10.0 sen gross per ordinary share (2008: 10.0 sen gross per ordinary share) less income tax of 25%, and a tax exempt dividend of 2.3 sen per ordinary share totalling RM425.3 million.

8) SEGMENTAL REPORTING

As the principal activities of the Group are the generation, transmission, distribution and sale of electricity in Malaysia, additional segmental reporting is deemed not necessary.

9) VALUATION OF PROPERTY, PLANT & EQUIPMENT

The Directors have applied the transitional provisions of International Accounting Standard No. 16 (Revised) "Property, Plant and Equipment" as adopted by MASB which allows the freehold land, leasehold land, buildings and civil works to be stated at their previous years' valuations less depreciation. Accordingly, these valuations have not been updated.



10) MATERIAL EVENTS SUBSEQUENT TO THE END OF THE REPORTING PERIOD

There were no material events subsequent to the end of the reporting period.

11) CHANGES IN THE COMPOSITION OF THE GROUP

There were no material changes in the composition of the Group during the reporting period.

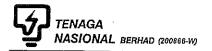

14) REVIEW OF PERFORMANCE

Performance of the current three months ended 30 November 2009 (FY2010) against the corresponding three months ended 30 November 2008 (FY2009):

Revenue for the three months ended 30 November 2009 decreased to RM7,338.3 million from RM7,414.6 million, a reduction of RM76.3 million or 1.0%. This was mainly due to the decrease in tariff effective from March 2009. However, in terms of unit sales growth the Company recorded an increase of 2.7% compared to the corresponding period last year.

Profit attributable to equity holders of the Company for the period under review was RM706.3 million compared to a loss of RM944.1 million in the corresponding period last year, an increase of RM1,650.4 million or 174.8%. The higher profit reflected the impact of lower operating expenses mainly attributable by the reduced cost of fuel. It is also due to the lower forex translation loss of RM 45.4 million compared to RM 1,439.7 million in FY 2009.

EXPLANATORY NOTES

Economic Profit/ (Loss) ("EP/ (L)") is a measure of value created by a business during a single period by comparing the rate of return generated by the company against its cost of capital.

A significantly lower economic loss of RM149.3 million has been recorded this year, an improvement of RM250.1 million from RM399.4 million loss recorded in the previous year. The improvement resulted from a reduction in operating expenses by 6.1% compared with 43.8% growth in the same period last year.

*EBIT is defined as Operating profit adjusted for released of deferred income and other operating income.

15) MATERIAL CHANGES IN THE QUARTERLY RESULTS COMPARED TO THE PRECEDING QUARTER

Performance of the current quarter (1st Quarter FY2010) against the preceding quarter (4th Quarter FY2009):

Compared to the immediate preceding quarter, the Group's revenue of RM7,338.3 million was RM124.3 million lower than the preceding quarter revenue of RM7,462.6, a decrease of 1.7% mainly from lower sale of electricity during the quarter under review.

Operating expenses was lower by RM639.6 million from RM6,819.5 million to RM6,179.9 million or 9.4%. This was mainly due to the decrease in fuel costs.

The Group recorded forex translation loss of RM45.4 million compared to a loss of RM244.3 million recorded in the preceding guarter.



16) PROSPECTS

Financial Year 2009 (FY2009) has been a very challenging year for the Group. The global economic crisis had caused the electricity demand to weaken and the Group was also faced with higher operational costs.

Prospects for FY2010 thus far have been encouraging resulting mainly from the proactive measures carried out by the Government in overcoming the economic crisis.

The Group recorded improvement in demand especially for industrial and commercial sectors. However, the uncertainties on foreign exchange rate for Dollar and Yen, and fuel price fluctuations remain. Managing operational costs will continue to be a challenge for the Group with the improvement in economic conditions and higher demand for coal. Nonetheless, the Group shall continue to enhance and strive to improve efficiency and productivity and quality supply of electricity to our customers.

Given the foregoing scenario, the Board of Directors expects the Group's performance for the year ending 31 August 2010 to be satisfactory.

23) OFF BALANCE SHEET FINANCIAL INSTRUMENTS

TNB has certain financial instruments including assets and liabilities incurred in the normal course of business. As part of its risk management's strategy, the Company manages its exposure to market rate movements of its financial liabilities through the use of derivative financial instruments. Virtually all foreign currency contracts are denominated in US Dollar and Japanese Yen.

TNB has entered into interest rate swap (IRS) agreements as well as currency option agreements, which mature from year 2015 to 2034. TNB has entered into these derivatives to reduce its exposure to losses resulting from adverse fluctuations in interest rates or foreign currency exchange rates on underlying debt instruments.

The details and the financial effects of the derivative financial instruments that TNB has entered into are substantially described in note 29 to the financial statements of TNB for the financial year ended 31 August 2009 (pages 260-262 of TNB's Annual Report).

There have been no material changes to the derivative financial instruments described therein between 2 November 2009 (being the date of financial statements) and the date of this announcement.



23) OFF BALANCE SHEET FINANCIAL INSTRUMENTS (continued)

As at 13 January 2010, the outstanding notional principal amount of derivative financial instruments entered into by the Group was RM2.09 billion. While this amount represents the total notional principal amount of outstanding off balance sheet financial instruments, it is not a measure of the extent of risks exposure to TNB.

All the above instruments were executed with creditworthy financial institutions and the Directors of TNB are of the view that the possibility of non-performance by these financial institutions is unlikely on the basis of their respective current financial strength.

24) MATERIAL LITIGATION
